Student Code of Conduct

Smoking & Vaping:

Smoking and vaping is not permitted on any school district property in the province of British Columbia and is not permitted on field trips or any events related to school.

Smoking and Vaping within the building or on campus may result in progressive discipline which may include student suspension.

Cell Phone Use:

Research suggests that restricting the use of personal digital devices at school leads to improved student wellness and academic focus. The use of personal digital devices during instructional time, is limited to instructional purposes and digital literacy in a way that is appropriate to the students' age and developmental stage, under the direction of the classroom teacher. Consideration will be given to: accessibility and accommodation needs, medical health needs, equity to support learning environments & use of personal digital devices for appropriate educational purposes.

Expected Behaviour:

- Contributing positively to the school community
- Solving problems in peaceful ways (no physical or verbal aggression)
- Adhering to the Personal Digital Device expectations
- Valuing diversity (combat racism, support gender, equity and identity and cultural practices) and defending human rights (according to the BC Human Rights Code)
- Honour learning time as valuable (attend on time, provide a note or parent phone for absence, sign out at the office with parent permission)
- Maintain academic integrity by not submitting work that is not your own
- Respectful interactions with students, staff and community members
- Respect the law as it applies to yourself and others
- **Speaking up and reporting incidents that demean others or threaten the personal or emotional safety of individuals or groups**

Unaccepted Behaviour:

- Engaging in incidents of harassment, intimidation, bullying or discrimination
- Interfering with the learning or orderly environment of the school or function
- No smoking/vaping on school property
- Verbal threats of harm, swarming
- Disrespect to others and their property
- Implicit or explicit acts of sexism, racism, and homophobia.
- Breaching academic integrity.
- Possession of weapons, with or without the intent of school use.
- Illegal acts such as: theft or damage to property, plagiarism, possession or distribution of an illegal or restricted substance, possession, use of a weapon or physical violence
- Taking photos or videos of other students/staff at any time without their explicit consent. At no time will students be permitted to take photos or videos of others in washrooms or changerooms.
- As a student of John Barsby Community School, you should never be on another school campus during the school day, or in their buildings without having an approved visitor pass from a school administrator.

Progressive Discipline

NLPS Inclusion Policy states:

"The Board expects that all students, staff, and members of our school communities will adhere to a code of conduct that is educative, preventative and restorative in practice and response"

Restorative Practices

- Focus on creating conditions for students to learn self-discipline, fix mistakes and return to the group/class/school strengthened.
- Address the needs of those who have been harmed
- Encourage the students, as often as possible, to participate in the development of meaningful, interventions through discussion or mediation to replace, repair or make "good" what has been taken, damaged, destroyed and/or defaced.
- Emphasize the importance of positive relationships in building community and,
- Speak to the obligation we all have to each other to move towards wholeness, restoration and belongingness.

Participating in a meaningful consequence may include:

- A 'do over' opportunity
- Face to face meetings with staff to address the harm done
- Group or classroom circles to restore equity, balance and respect
- An act of service to make a positive contribution to the class, school or community
- School/community support to learn and practice problem solving or conflict resolution strategies
- Reflective/think process that includes the opportunity to create a plan to restore the harm done
- Restorative practices involving families of those harmed and doing the harm

Student Suspension

Discipline measures used with students should be viewed the context of helping students achieve intellectual and social development. The purpose of suspension, or any other discipline strategy, should be to meet these provincial goals and to develop self-reliant adults. Suspension is one strategy in a more complex problem-solving process designed to support the student in changing inappropriate behaviour.

Notification

School administration may advise other parties or agencies of serious breaches of the code of conduct depending on the severity and/or frequency of misconducts and the impact on others and/or the school community. Illegal acts will be reported to the RCMP and/or District Administration to develop a safety plan that will include the components of education, prevention and restorative action.
